# **Child Trafficking Database**





A learning program for all ACS and provider agency direct service and supervisory staff working directly with children aged 18 and younger.

## **ABOUT**

This eLearning program prepares learners to navigate the Child Trafficking Database (CTDB), an electronic tool used to assess youth who may be at risk for sex trafficking. Learners will explore the purpose and practical application of the federal, state and New York City assessment, reporting and documentation mandates that protect potential victims. During this training, learners use demonstrations, guided practice and a case scenario to practice the steps needed to complete a sex trafficking screening. Before attending this eLearning training, learners must complete an online pre-test.

### BENEFITS

Learners will:

- Be able to understand the importance of the CTDB in the assessment, reporting and documentation of youth who may be at risk for sex trafficking.
- Be trained to complete the steps necessary to conduct a proper sex trafficking screening.
- Be able to identify and select sex trafficking indicators and the corresponding youth service needs.
- Recognize when law enforcement must be notified and the required follow-up procedures.
- Become familiar with the services and resources provided by ACS' Office of Child Trafficking Prevention and Policy (OCTPP)

## **COMPONENTS**

Once enrolled in the course, learners will complete:



An online pre-test.



A one-hour eLearning course.



An online post-test.



Completion of all components is necessary to receive a Certificate of Completion.
